The following Commissioner(s) commented on the following: Commissioner Phillips asked in regards to what Crockett was. Mr. Helms commented it is in reference to the property 110 Anchor Way that is now Porcini's. Commissioner Phillips asked in regards to what card member services was. Mr. Helms commented it is in regards to the pre-paid merchandise for the aift shop. Commissioner Phillips asked why did we tint the windows. Mr. Helms commented it was a replacement for Englund Marine. Commissioner Phillips asked in regards to Eureka Humboldt Fire services. Mr. Helms commented it was to replace valves and fire extinguishers. Commissioner Bailey commented if it included replacing fire extinguishers in the vehicles. Mr. Helms commented he would check with Eureka Humboldt Fire and make sure. Commissioner Phillips asked in regards to Red Sky putting in the garage door. Mr. Helms commented Red Sky was the only company that could provide that service. Vice President Feller asked in regards to the backhoes final payment in the amount of \$1.08. Mr. Helms commented he would check on it and see if we paid it off.

2. Discussion and consideration of the purchase of a car wash water recycling system for the facility leased by Little Hawk Performance and Repair at 730 Highway 101 South. Take action as necessary and appropriate

Discussion was held in regards to the purchase of a car wash water recycling system for the facility leased by Little Hawk Performance and Repair. Mr. Helms commented the water conversation bill requires all newly purchased car washes to use 60% of recycled water. Mr. Helms commented Aaron prepared a document that shows what he is using and what procedures he is following and he losing money on every car wash because of the water conversation bill. Commissioner Phillips asked what the cost would be. Mr. Helms commented it would \$30-

\$35,000.00. Commissioner Phillips asked if it could be leased. Mr. Helms commented he would look into it. Commissioner Phillips asked if this would cut down on his water use. Mr. Helms commented that it would. Commissioner Phillips suggested leasing the system with a 5-year term. Mr. Helms commented he would check on it and hopefully cut the water usage by 80%. Commissioner Phillips asked if there is anyone in the city who knows if we can apply for a grant to fund this project. Mr. Helms commented he would ask Eric Taylor with the City. Mr. Helms commented Aaron has a deal with logging company so the drivers can come in and wash the trucks. Commissioner Bailey asked if this system required a better filter process. Commissioner Phillips asked if the Harbor could install the system ourselves. Mr. Helms commented that Aaron would take care of the installation. Vice President Feller commented to check with boating water waste. Mr. Helms commented there is a grant for water improvement savings.
